FACULTY AND STAFF NOTES

ASSISTANT DEAN JOHN FARAGO is serving as 1981 secretary of the American Association of Law Schools sections on Pre-Legal Education and Law and Education. His article on law, ethics, and academic administration, entitled "Academic Chivalry" appears in the March 1981 volume of New Directions in Higher Education. A recent volume of our own law review contained his review of The Brethren as well as his article called "Judicial Cybernetics." The New York University Law Review (volume 55) included Dean Farago's article "Intractable Cases."

On March 13, PROFESSOR RICHARD STEVENSON lectured on evidence at the Indiana Continuing Legal Education Forum held in South Bend.

PROFESSOR DIERDRE BURGMAN presented a talk entitled "Constitutional Issues in Family Law" at a Family Law Seminar in Indianapolis in November. The seminar was jointly sponsored by the Indiana Bar Association's Section on Family Law and the Indiana Continuing Legal Education Forum. Videotapes of the seminar are currently being shown in various locations in Indiana. Her article, "Perish the Day of Birth," which appeared last fall in The Cresset, was recently discussed in a publication called "Forum Letter," which is published monthly by the American Lutheran Publicity Bureau. This fall, Ms. Burgman will join the litigation department of the New York City law firm of Dewey, Ballantine, Bushby, Palmer & Wood.

PROFESSOR PAUL H. BRIETZKE has been invited to Germany to present three papers in late May and June, 1981. The (German) Union of Comparative Constitutional Lawyers has invited him to deliver the keynote address at its Conference held at the University of Kassel. He will also present papers at two University of Munich Conferences: "The Ideologies of American Antitrust" and "Teaching Law and Economics." Following that he will deliver lectures at the Max Planck Institute in Freiburg and the University of Marburg Institute of Cooperative Law.

PROFESSOR JACK A. HILLER participated in a workshop on "The Economic Aspects of National Security and Foreign Policy: the Challenge to a Free Society" sponsored by the Standing Committee on Law and National Security and the International Law Section of the American Bar Association and held at the St. Louis University School of Law on December 12-13, 1980. Professor Hiller, who is the Chairman of the University's Museum Committee, attended a symposium, "A MIRROR OF CREATION: 150 Years of Nature Painting," on February 14th at Northwestern University.

PROFESSORS BRIETZKE and HILLER participated in a Symposium on Law and Development entitled "Law in Strategies of Alternative Development" at the University of Windsor Faculty of Law in Windsor, Ontario on March 19 to 21st. Both professors were chairmen of sessions of the Symposium and were commentators on papers presented.
