Professor Seymour Moskowitz

Seymour Moskowitz has rejoined our faculty as a full-time professor after three years at Touro College School of Law. He received his J.D. from Harvard Law School in 1966. Mr. Moskowitz has participated in such activities as the Connecticut State Labor Relations Board, the Program Committee of the Labor and Employment section of the Connecticut Bar Association, consultant for the N.Y.S. Legislative Task Force on Women's Issues, and volunteer attorney for the Connecticut Civil Liberties Union. He was also a founder of Project Justice and Equality, a law reform organization which has long supervised clinical work at the law school.

David R. Yoder, a 1974 School of Law alumnus and Executive Director of the Legal Services Program of Greater Gary, Inc., has joined the faculty as a clinic adjunct professor. Mr. Yoder is a member of the ABA, the NLADA, the Michigan Bar Association, ISBA, Indiana Trial Lawyers Association, Porter County Bar Association, and Thurgood Marshall Bar Association. He serves on the Indiana Civil Liberties Union Board of Directors and Legal Panel, is Vice President of the Indiana Legal Services State Support Center Board, is a trainer for various legal services corporation funded programs including family law, professional work supervision and high quality representation.

Professor Ivan Bodensteiner taught a CLE program in Civil Rights with Professor Rosalie Levinson on October 5. Professor Bodensteiner also taught CLE Programs on Federal Court Litigation in Toledo, Ohio, on October 17 & 18, and in Detroit, MI, on November 14 & 15.

Professor Levinson gave a November 6 lecture on Politics and Religion for ETC; was interviewed on November 28 by Kate McGovern for the Porter Cable Program on Church & State; and will publish her inaugural lecture, "Separation of Church & State: And the Wall Came Tumbling Down" in the Valparaiso Law Review in December. She also lectured on Constitutional law in the August Indiana Law Update which is sponsored by the Indiana Continuing Legal Education Forum.

Government Documents Librarian Sally Holterhoff was awarded a grant by the American Association of Law Libraries to attend its annual meeting in San Diego. She was program chairman for a session on "Availability of Government Information On-line."

Professor Paul Brietzke will publish "Public Policy: Contract, Abortion, and the CIA" in the Valparaiso Law Review and "Development as a Human Rite" in the 1984 volume of Third World Legal Studies. Professor Brietzke and Professor Jack Hiller led a seminar in graduate legal education for interested students on September 27. On October 10 Professor Brietzke participated in a Student's International Law Society panel discussion on South Africa. He attended the African Studies Association conference in Los Angeles, October 25-28, to listen to papers presented, chair a session, and meet with other members of the African Studies Review Editorial Board. On November 29, Professor Brietzke gave a brown-bag lunch talk to University faculty on "The Ideologies of Antitrust." He has also been invited to present a paper to an American Society of International Law Conference in San Diego February 22-23.

Professor Jack Hiller participated in the September 20-22 Association of American Law Schools' workshop on teaching public international law, international business transactions and comparative law in Chicago. He also gave a talk to the Exchange Club of Valparaiso on "Law, Language, Sports and Culture" on November 6. Professor Hiller was Session Chairman and participant in The 9th Symposium on Law and Development, "Education for Alternative Development: Generating and Sharing Knowledge of Law" which was held November 8-10 at the University of Windsor in Ontario, Canada. Professor Hiller has also published "The Law-Creative Role of Appellate Courts in the Third World" in *Essays on the Third World Perspective in Jurisprudence*.

Chairman of the Board of Visitors of the School of Law, Member of the University Board of Directors and 1977 recipient of the Distinguished Alumni Award, Mr. Duesenberg has his B.A. (1951) and J.D. (1953) from Valparaiso as well as an LL.M. from Yale (1956). He has worked with the Monsanto Company since 1971.

He is actively involved in activities such as the American Bar Association, American Law Institute, American Society of Corporate Secretaries, Association of General Counsel, Missouri Bar Association, St. Louis Bar Association, American Judicature Society, International Bar Association, Legal Advisory Committee of the New York Stock Exchange, Chemical Manufacturers Association, The Great Plains Legal Foundation, The Southwestern Legal Foundation, The Corporation Law Review, the Business Roundtable, the National Association of Manufacturers, the National Center for Administrative Justice, the Administrative Conference of the United States, the Practicing Law Institute, and the Center for Public Resources.

In addition, Mr. Duesenberg has published numerous legal publications, books, law review articles, and book reviews as well as given major addresses and seminars on a broad range of subjects.

Judicial Clerkships

The trend of Valparaiso law graduates accepting judicial clerkships continues. 10% of the Class of 1982 accepted clerkships and 7.6% of the Class of 1983 accepted clerkships. Although an official survey has not yet been taken of the Class of 1984, unofficially, 11.7% have accepted clerkships. Courts Hear Oral Arguments in Law School

Recently the Supreme Court and the Appellate Court of Indiana heard oral arguments in the School of Law Courtroom.

On October 29, the Appellate Court heard arguments in the cases of *State Farm Life Insurance v. Fort Wayne National Bank*, a case involving the alleged negligent preparation of a life insurance policy; and *Taylor-Chalmers v. Board of Commissioners of LaPorte County*, a case involving inverse condemnation without physical control of the land. Judges William P. Gerard, George B. Hoffman and Robert H. Staton presided over the arguments and answered questions from the audience following the arguments. Afterwards, there was a reception in the main lobby.

The Supreme Court heard arguments on November 8 on the case of *Cha, et al. v. Warnick*. This was a challenge to the constitutionality of the Medical Malpractice Act of Indiana as it is applied. Justices Richard M. Givan, Dixon W. Prentice, Robert O. DeBruler, and Alfred J. Pivarnik heard the arguments and answered the audience's questions after the presentation. A reception followed in the lobby.

The School of Law would like to thank the members of both the Supreme and Appellate Courts for taking the time to travel to Valparaiso. Attending the oral arguments and being able to ask questions provided a unique learning experience for the students who greatly appreciated the opportunity.
